Registration Form for Exhibiting Artwork

In order to be eligible to exhibit your artwork with Sunnyvale Art Club sponsored exhibit venues, exhibits, and our Art-On-Loan program, we require all participants to fill out and sign (with email address) this **Registration Form for Exhibiting Artwork**, and a **Sunnyvale Art Club Release of Liability** form on the next page. Please return all three forms either by email or by regular mail along with your check for the membership.

If you wish to exhibit, we must have these forms on file with your signature/date. (Please Print) Name_____ (Please list the email address with which you registered your membership and is the one where you receive email from Sunnyvale Art Club.) I have read and agree to the Release of Liability form (on the next page). I understand that I will prepare my artwork for safely hanging with approved wire and hardware, attached with screws into the wood frame (not the canvas stretchers unless no frame is attached), and that the frame and artwork are in good condition. If the frame is plastic, glass or other material, I will ensure that the hanging bracket is appropriately installed and will be subject to the approval of the exhibit coordinator prior to hanging. At the exhibit location, I will not move hangers already installed on the walls or change wall hardware unless the vendor/exhibit venue manager gives permission. I will not remove the artwork of any other member without their prior, express written permission. If I do so and it is damaged, lost, stolen, or otherwise marred, it will be my personal financial obligation. I will also be suspended from exhibiting for a period determined by the Sunnyvale Art Club Board. I understand that this agreement is intact until written cancellation by the artist is received by Sunnyvale Art Club, P.O. Box 2744, Sunnyvale, CA 94087. Date signed Signed



Sunnyvale Art Club Release of Liability

Artist/Exhibitor agrees that **Sunnyvale Art Club or the venue in which your art is exhibited** shall not be liable for any injury to Artist/Exhibitor, their personnel, agents, or employees or for any damage or loss of Artist's/Exhibitor's work, equipment, or other personal property arising out of the above exhibitions/displays, the mounting, hanging, and/or any other activities involved in the preparation and/or presentation of the exhibitions/displays. Artist/Exhibitor agrees to assume all risk of damage to or loss of their own art from whatever cause. Artist/Exhibitor further agrees to release and to hold harmless **Sunnyvale Art Club or the venue in which your art is exhibited** including its officers, directors, employees, volunteers, and agents from any and all liabilities and damages to artwork and/or persons as a result of an Artist's/Exhibitor's participation in the exhibit.

INDEMNIFICATION: ARTIST/EXHIBITOR SHALL INDEMNIFY, SAVE AND HOLD HARMLESS SUNNYVALE ART CLUB, ITS OFFICERS, DIRECTORS, EMPLOYEES, VOLUNTEERS AND AGENTS AND THE PARTICIPATING EXHIBITION VENUES FROM ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION AND JUDGMENTS, LOSSES, COSTS AND EXPENSES, INCLUDING BUT NOT LIMITED TO REASONABLE ATTORNEYS FEES, ARISING DUE TO THE NEGLIGENCE OF ARTIST/EXHIBITOR, THEIR EMPLOYEES, AGENTS OR OTHER PERSONNEL HEREUNDER, INCLUDING BUT NOT LIMITED TO ANY REPRESENTATION, WARRANTY, TERM AND/OR CONDITION OF THIS AGREEMENT.

Insurance: Artist/Exhibitor shall be solely and exclusively responsible to insure properly and adequately their work and property.

Assignment: Neither Party shall assign to transfer any of its rights or obligations under this Agreement and any attempt to do so shall be void and of no effect.

Waiver and Effective Nullity: Waiver by either party of any provision of this Agreement shall not operate or be construed as a waiver of any provision by such party at any time hereafter. The nullity of any provision hereunder shall not affect the validity or enforceability of the remaining provisions hereunder of the Agreement, which shall survive.
